### PRO-RATA FEES

The fees for registration of dogs and cats over three months of age, being registered for the first time after 10 October shall be one half of the applicable annual Council fee.

### REFUND OF FEES

Where any dog or cat which has been registered for the full year dies within six months of the commencement of the registration year the owner shall be entitled to a refund of one-half of the registration fee paid.

### PRIVACY NOTIFICATION
