Cr. Myra Murrihy nominated Cr. Jordan Lockett for the position of Mayor for the 2025/2026 term.

Cr. Lockett accepted the nomination.

Cr. Susan Taylor nominated Cr Jim Doukas for the position of Mayor for the 2025/2026 term.

The Chief Executive Officer called for a show of hands for each candidate:

Cr Jordan Lockett received 4 votes - Cr. Foster, Cr. Lockett, Cr. Murrihy, Cr. Ryan Cr Jim Doukas received 3 votes - Cr Doukas, Cr Ross, Cr Taylor

2.1 S11A Instrument of Appointment and Authorisation Planning & Environment Act 1987

Overview: This instrument can be used by a council to authorise officers to enforce the *Planning and Environment Act 1987* and institute proceedings on behalf of the council or represent the council.

Cr Myra Murrihy moved, Cr Lloyd Ross seconded In the exercise of the powers conferred by s 147(4) of the Planning and Environment Act 1987, Moyne Shire Council (Council) resolve that –
