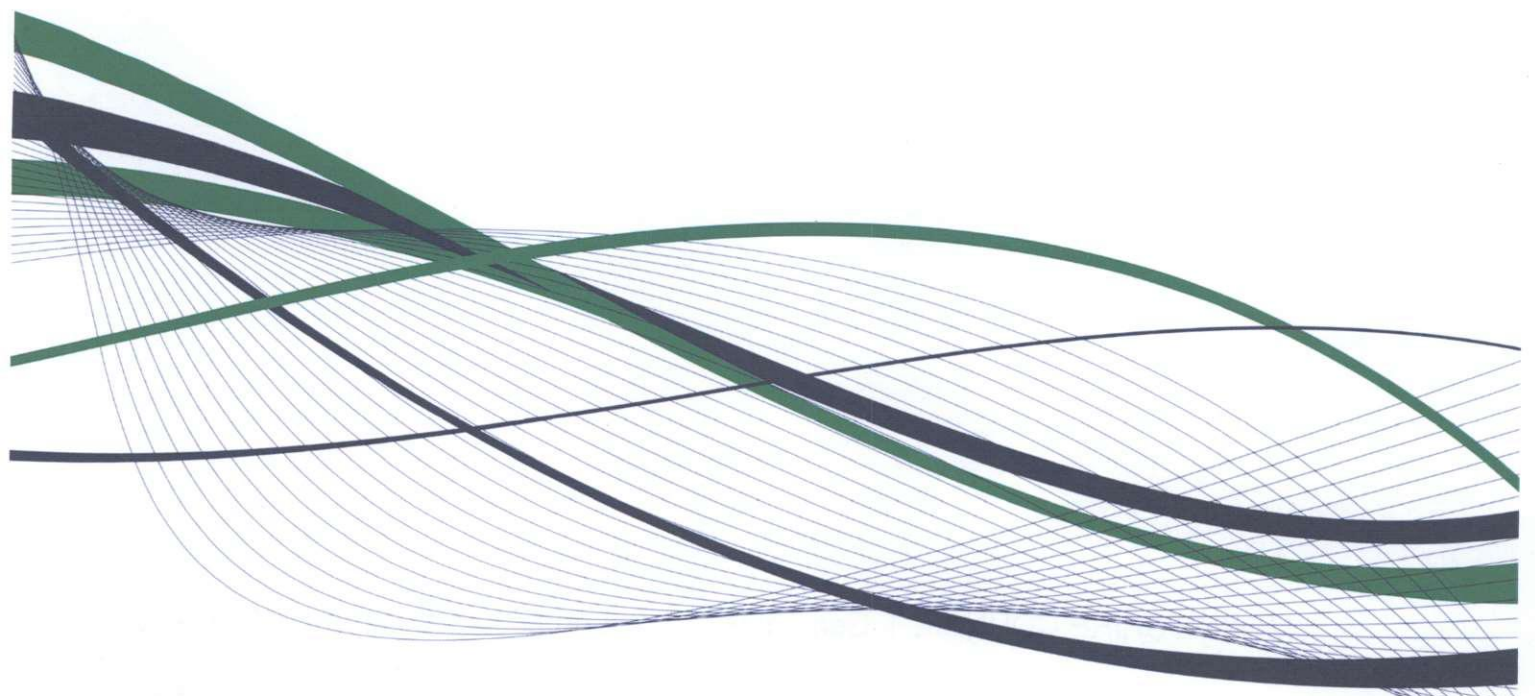

PART A – INTRODUCTORY

TITLE

This Local Law is the Moyne Shire Council "General (Amendment) Local Law No.3" and is referred to below as "this Local Law".

OBJECTIVE OF THIS LOCAL LAW

The objectives of this Local Law are to:

- 1.1. Amend General Local Law No.1-2015 in order to delay the introduction of the annual dog restriction period on Port Fairy beaches until Christmas Eve;
- 1.2. Reduce the disruption to and predation of shore nesting birds, in particular, hooded plovers; and
- 1.3. Provide generally for the peace, order and good government of the Municipal District.

ENABLING POWER AND COMMENCEMENT

- 1.4. This Local Law is made under section 111 of the *Act*.
- 1.5. This Local Law comes into operation on the day after it is made.

DATE THIS LOCAL LAW CEASES OPERATION

Unless this Local Law is revoked sooner, its operation ceases on the day on which the *Principal Local Law* ceases to operate.

SCOPE AND STATUS OF THIS LOCAL LAW

This Local Law operates throughout the *Municipal District*.

DEFINITIONS

In this Local Law, unless inconsistent with the context:

Act means the *Local Government Act 1989*;

Council means Moyne Shire Council

Municipal District means the district under the local government of the Moyne Shire Council

Principal Local Law means General Local Law No.1-2015, made by *Council*.

Where a word or phrase has a particular meaning, other grammatical forms of that word have the same meaning.

PART B – AMENDMENTS TO PRINCIPAL LOCAL LAW

AMENDMENTS TO PART 1

- 1.6. Immediately after clause 11.31, insert clause 11.31A:

***"Identified Hooded Plover Nesting Site** means a hooded plover nesting site that has been marked with temporary fencing and/or signage."*

AMENDMENTS TO PART 7

- 1.7. Immediately after clause 41.3, insert clause 41.4:

"At all times, dogs must be on-lead within 50 metres of any Identified Hooded Plover Nesting Site located on the beach or in the dunes in Port Fairy south of Connelly Street on East beach and east of Anna Catherine Reserve on South beach."

AMENDMENTS TO SCHEDULE 6-PORT FAIRY

- 1.8. Immediately after the map of Port Fairy, delete the text:

"Orange = Dogs prohibited between 9am and 6pm 1 December to Easter Monday inclusive"

and substitute:

"Orange = Dogs are prohibited between 9am and 6pm Christmas Eve to Easter Monday inclusive."

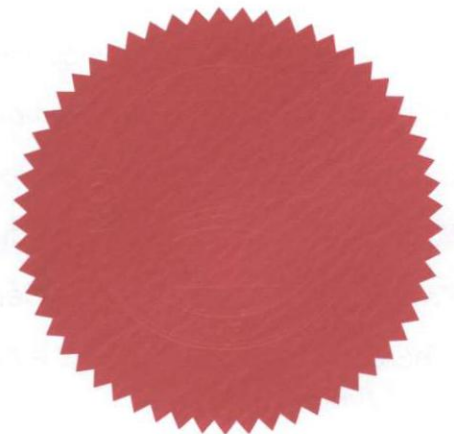
